## TOUR PARTICIPANT AGREEMENT

**BY SIGNING MY NAME BELOW, COMPLETING THE REGISTRATION PROCESS AND PARTICIPATING IN REDISCOVERING OUR MYTHICAL & PSYCHOLOGICAL ROOTS IN GREECE WITH DR JERRY WRIGHT, I EXPRESSLY AGREE TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THIS TOUR PARTICIPANT AGREEMENT. I understand that the Tour is offered to me conditioned on my acceptance, without modification, of the terms and conditions contained in this Tour Participant Agreement.**

I acknowledge and agree as follows:

1. I have read and agree to be bound by the Brownell Travel, Inc. ("Brownell") Terms and Conditions listed on the Brownell website <https://www.brownelltravel.com/about-brownell/terms-of-service/> including the release of Brownell from liability for any personal injury or property damage.
2. I am fully informed or otherwise aware of, and fully assume, all risks to person and property in connection with my participation in the Tour, including, but not limited to, property damage and loss, bodily injuries, sickness, disease and death. I am in sufficient physical and mental health to participate in the Tour and do not have any physical or mental conditions which could affect my ability to participate in the Tour. I have medical insurance coverage appropriate for my participation in the Tour and understand that neither Beyond Leisure nor Brownell shall provide any insurance for me in connection with my participation in the Tour, and Travel Protection/Insurance is NOT automatically included in the cost of the Tour to protect against third party default, delay, trip interruption, trip cancellation, emergency medical expenses, emergency medical evacuation/repatriation, baggage loss, baggage delay, and more. Travel Protection/Insurance is offered and recommended for everyone. If I do not elect to purchase travel protection/insurance, I understand that I am responsible for all consequences, including all charges, regardless of the reason a trip is not taken.
3. I hereby affirm I read the schedule of Tour activities, choose to voluntarily participate, and engage in the Tour and any recreational activities that are part of the Tour, or any other activities that I choose to engage in, and I certify that I am fully aware of and expressly assume all risks involved with such activities.

The increase or decrease of participants affects the Tour price. All Tour payments are non-refundable. If I decline to purchase trip insurance, I accept the consequences of non-coverage.

This Agreement shall be interpreted and enforced in accordance with the laws of the State of Alabama, without regard to any conflicts or choice of law principles and shall be as broad and inclusive as permitted by such laws. If any provision of this Agreement is held unenforceable by a court, such unenforceability shall not affect any other provision.
7. I accept that Dr. Jerry Wright ("Wright"), Yeardeley Williams ("Williams") and Brownell are not responsible for, nor will I attempt to hold either Wright, Williams, or Brownell liable for, any injury, damage or loss I may suffer on account of any conditions, actions or omissions that are beyond their reasonable control.
